### Job Description

Under the Direct Supervision of the Utility Engineer, the Construction & Inspection Workman will perform a variety of duties related to water and wastewater infrastructure ranging from inspection of existing and/or proposed water and wastewater facilities to installation/construction of infrastructure. Infrastructure includes but is not limited to pipes, valves, fire hydrants, manholes, services, pump stations and specialized process equipment at water and/or wastewater treatment facilities.

## **Job Responsibilities**

- 1. Reviews construction plans & specifications.
- 2. Checks material used on-site vs material specified in construction plans and specifications.
- 3. Maintains records of material and/or contractor quantities and field logs.
- 4. Documents field changes to plans and specifications.
- 5. Coordinates construction activity with contractor, engineer, developer and other utility companies.
- 6. Performs inspections and/or construction activities and will report on a daily basis to Workman IV as the supervisor on site.
- 7. Operates Heavy Machinery to assist in Trenching for Pipe Installation and other infrastructure placement.
- 8. Performs hand digging, construction and installation of infrastructure such as pipes, valves, fire hydrants, manholes, services, pump stations and specialized process equipment at water and/or wastewater treatment facilities.
- 9. Other duties as assigned.

## **Knowledge, Skills and Abilities**

- 1. Job requires an accredited high school diploma or GED equivalent.
- Position requires a minimum of 3 years of experience in general civil infrastructure construction. The experience may have been achieved at either a Municipal Inspector Position and/or a Private Sector Constructor.

- 4. Job requires a current, valid Texas Class C driver's license. However, a commercial drivers license is preferred.
- 5. Employee must be able to interpret design data from engineering plans and specifications.
- 6. Employee must be able to assertively and tactfully handle situations that arise in the field and be able to concisely, and effectively communicate field conditions and directives.
- 7. May require attendance at required seminars and continuing courses.
- 8. Must have the ability to perform effectively with little supervision in various work situations having deviations and irregularities.
- 9. Must have basic level computer skills and be familiar with Microsoft Office software.
- 10. Familiarity with construction surveying equipment, standard Utility Trenching Requirements, PVC Pipe Installation Procedures, Fiberglass Manhole Installation Procedures, Traffic Safety Implementation Procedures and Heavy Duty Equipment Operator experience is preferred.

#### **Physical Demands**

- 1. Physical effort involves walking on construction sites, driving and climbing.
- 2. Work is primarily outdoors. Construction hazards exist that may result in lost time, accident, exposure to soiling of clothing and skin surfaces. Work involves normal weather changes.
- 3. Lifting of heavy material is occasionally expected.
